**ROUTING OF REQUISITIONS BY CPSEs FOR PROVISION OF MANPOWER FOR SECURITY ONLY
THROUGH DGR: GoI ORDERS**

1. Please refer to the following letters:-
 - (a) DPE OM No. DPE-GM-12/0001-2016-GM-FTS- 5410 dt 13 Sep 2018 & 14 Feb 2019 **(Copy att)**.
 - (b) MoD OM No. 28(03)/2012/D (Res-I) dt 09 Jul 2012 and amended vide OM even No. dated 16 Jan 2013 **(Copy att)**.
 - (c) DGR letter No. 2112/SA/2828/Emp dt 11 Feb 2016 and even No. letter dated 18 Apr 2019. **(Copy att)**.

2. Apparently there is an ambiguity for routing of requisitions to different 'Service Providers' for provision of manpower for security (in the instant case – DGR or State ESM Corporations). The same has been clarified (with reasons) in letters quoted at Para 1 above.

3. **Procedure/ Guidelines:** Salient points on the procedure of Requisitions by CPSEs for Security Agencies only through DGR based on authority of Govt of India letters quoted at Para 1 above are reiterated below:-

(a) Requisitions for Security Agencies **will only be routed through DGR** and not through State ESM Corporations.

(b) State ESM corporations will continue to be empanelled by DGR as per the provisions of Para 3 of MoD OM **albeit based on their credentials**. State ESM corporations will be considered for sponsorship under the provisions of Para 15 (c) and Para 19 of MoD OM subject to its cyclic order of seniority (in its Parent State only), current running guards, requisitions available for sponsorship and total number of security agencies empanelled in respective State to ensure equal opportunities to all ESM registered with DGR.

(c) State ESM corporations **will not operate outside its Parent State** without approval from DGR and will forward its request to DGR regarding States in which it intends to operate. DGR will consider Ex-Servicemen Corporations for sponsorship for CPSUs in such States and also recommend it for State Establishments.

4. Apropos, following actions are requested:-

(a) CPSUs to conclude all contracts not compliant with directions given above and forward fresh requisition for sponsorship of security agency/ guard through DGR.

(b) Cognize instructions as contained in letters quoted at Para 1 above and other orders with regard to operations / sponsorship or award of contract for security agency.

5. Requisition for security agency contracts through DGR by your institution / agency is a token of appreciation towards the soldiers (now ESM) for having rendered their services to the 'National Security' in their prime youth.

6. This has the approval of competent authority.
